#### What is this Product?

### Product Type:

Undertaking for Collective Investment in Transferable Securities (UCITS) Fund.

# Currency:

## Investment Policy:

The Investment Manager ("We") are expected to invest primarily either directly or indirectly in a portfolio of corporate and/or government bonds being either listed or unlisted but having no particular duration. Indirect exposures may be achieved through investments in The investment objective of the Sub-Fund is to achieve long-term capital growth. There is no ETFs, other collective investment schemes and derivative instruments. # What happens if AQA Capital Limited is unable to pay out?
